SUBJECT RELATIONSHIP BETWEEN THE ARGENTINE PEOPLE'S  
REVOLUTIONARY ARMY (ERP) AND THE REVOLUTIONARY  
COORDINATING JUNTA (JCR)

1. IN EARLY APRIL 1976, "LORENZO," A LEADER OF THE ARGENTINE PEOPLE'S  
REVOLUTIONARY ARMY (ERP) IN JUJUY PROVINCE, ELABORATED ON THE RELATIONSHIP  
BETWEEN THE ERP AND THE REVOLUTIONARY COORDINATING JUNTA (JCR).  
COMMENT: THE JCR IS A GUERRILLA COORDINATING BODY WHOSE MEMBER ORGANIZATIONS  
HAVE PREVIOUSLY BEEN IDENTIFIED AS THE ERP, THE CHILEAN MOVEMENT OF THE  
REVOLUTIONARY LEFT (MIR), THE URUGUAYAN NATIONAL LIBERATION MOVEMENT (MLN-  
TUPAMAROS) AND THE BOLIVIAN ARMY OF NATIONAL LIBERATION (ELN).

2. "LORENZO" STATED THAT THE JCR HAS IDEOLOGICAL INDEPENDENCE, PREPARES  
PLANS FOR OPERATIONS IN COUNTRIES WHERE THE JCR IS REPRESENTED, EXCEPT IN  
ARGENTINA, AND THEN PRESENTS THESE PLANS TO THE ERP FOR FUNDING AND LOGISTICAL  
SUPPORT. "LORENZO" GAVE THE IMPRESSION, THEREFORE, THAT THE ERP CONTROLS THE  
JCR BY ITS FUNDING BUT ALLOWS THE JCR TO SUPERVISE AND BE RESPONSIBLE FOR THE  
ACTUAL ALLOCATION OF THE MONEY FOR THE SPECIFIC OPERATIONS IN THE COUNTRIES  
CONCERNED. "LORENZO" IMPLIED, HOWEVER, THAT THE RECENT SUCCESSES OF THE  
ARGENTINE SECURITY FORCES AGAINST THE ERP HAVE CAUSED A SETBACK IN THE ERP'S

PROGRESS IN CHILE IT HAS NOT BEEN SUCCESSFUL IN BOLIVIA OR  
URUGUAY.

PROGRESS IN CHILE CONCERNS THE FORMATION OF SMALL RESISTANCE  
UNITS. "LORENZO" ALSO NOTED [redacted] THAT A  
PROBLEM WITH THE JCR IS THAT REPRESENTATIVES HAVE BEEN  
SOFTENED BY THE COFFEE HOUSES AND GOOD LIFE OF EUROPE.

[redacted] ON 29 MARCH 1976 THE FEDERAL POLICE RAIDED A  
TOP-LEVEL CONFERENCE OF THE JCR WHICH WAS BEING PRESIDED  
OVER BY THE CENTRAL COMMITTEE OF THE ERP, ALONG WITH THE  
REVOLUTIONARY WORKERS PARTY, THE POLITICAL ARM OF THE  
ERP. REPRESENTATIVES WERE PRESENT AT THE CONFERENCE FROM  
THE MIR, MLN-TUPAMARUS AND ELN. SOME PARTICIPANTS WERE  
KILLED IN A SHOOTOUT WHICH OCCURRED DURING THE RAID AND  
OTHERS WERE CAPTURED. [redacted]
