According to reports received by Amnesty International, the twelve members of the Comision de Cuidadanos Por el Voto en Blanco who were arrested on 20 October 1982 have been released. Francisco Ortomelli, Carlos Gomez Haedo, Oscar Botinelli, Ruben Figueredo, Juan José Sirichu, Carlos Zubillaga, María Josefina Pla, Héctor Fabregat, German Lezama, Alejandro Paternain, Carlos San Marco and Juan Carlos Doyemart were released by a civil court decision, probably on 23 October 1982.

In addition, two members of the Blanco party arrested on 20 October have been released - Carlos Pita and Tomas Larregui. It is believed that Carlos Pita has been indicted on a charge of crimes against "the morale of the armed forces" and that Tomas Larregui will also be charged with an offence under the Military Penal Code. Horacio Terra Gallinal and Rodolfo Sadain are reported to be still in custody following a decision by a military court confirming their detention. According to reports, they are charged with Escarnio a las instituciones constitucionales (disrespect for constitutional institutions), an offence classified under the Military Penal Code as a crime against "the morale of the armed forces".

Further recommended action:

No action of behalf of the twelve members of the Comision de Cuidadanos Por el Voto en Blanco.

Appeals on behalf of Horacio Terra Gallinal and Rodolfo Sadain should continue. Appeals should:

- express concern about the reported arrest of Horacio Terra Gallinal and Rodolfo Sadain, ask for the reasons for their arrest and request that they be allowed immediate access to a lawyer and to their families;
- urge their immediate release if, as the available evidence suggests, they have been arrested for the non-violent expression of their political opinions.

Appeals should be sent to the addresses given on the original Urgent Action.
