Your Excellency Carlos de Yeregui Lerena,

We respectfully seek your interest for this letter.

You will no doubt be aware that Amnesty International is an international organisation which works to promote and protect human rights as they appear in the Universal Declaration of Human Rights. Amnesty International is an independent impartial organisation, and has consultative status with the UN, UNESCO, the Council of Europe, the Organisation of American States, and is recognised by the Organisation of African Unity. The Dutch Section of Amnesty International has more than 30,000 members.

Saturday 10th December is Human Rights day. Amnesty is planning to give a lot of attention to this, the beginning of the 30th year of the Universal Declaration of Human Rights.

This will be by means of a number of activities on this day, the theme being 'speak for those who have to remain silent'. Attention will be focused upon seven prisoners of conscience, who have been detained due to their human rights activities.

The seven are:

Esquivel	- Argentine
Kim Chi-hay	- South Korea
Julio Castro	- Uruguay
Wreksoatmodjo	- Indonesia
Kovalyov	- USSR
Nefolovhodwe	- South Africa
Pavlucek	- Czechoslovakia

We urge that you do all within your power to ensure that the freedom of speech restrictions in your country cease and in doing so, arrange for the release of the above mentioned prisoner of conscience in your country. Since Amnesty International has made many appeals for the release of this prisoner, a demonstration will be held outside your embassy on Saturday, 10th December, 1977, to make his situation known to the public.

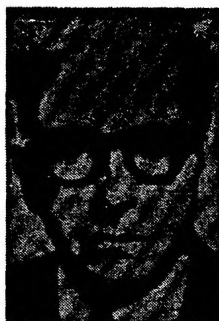

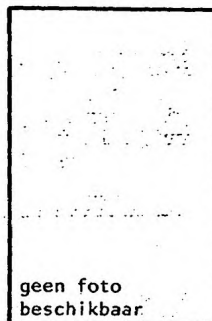

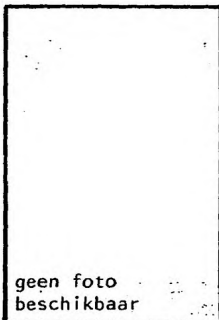

SPREEK VOOR HEN DIE MOETEN ZWIJGEN

In 1948 werd op 10 december de Universele Verklaring van de Rechten van de Mens aangenomen. Nu, drie decennia later, blijkt dat nog duizenden mensen vervolgd worden om hun ideeën, geloof, overtuiging of ras. Velen in de wereld zwijgen omdat ze anders gevaar lopen gearresteerd, gemarteld, vervolgd te worden.

Onderstaande mensen hebben niet gezwegen maar zich ingezet voor de verwezenlijking van de mensenrechten. Zij zijn het slachtoffer geworden van politieke repressie. Als zij met het risico van vervolging spraken, mogen wij niet zwijgen. Wij hebben de plicht onze vrijheid te gebruiken voor de vrijheid van anderen. U kunt dat doen door te schrijven:

Your Excellency,

Though I fully realize that there are other important matters claiming your time I would nevertheless ask your attention for the following. You will no doubt be aware that Amnesty International is an international organisation which works to promote and protect human rights as laid down in the Universal Declaration of Human Rights.

Saturday 10th December is Human Rights Day. On the occasion of this day I learned that the following persons have been detained due to their human rights activities. They are:

Esquivel	Argentina
Kim Chi-hay	South Korea
Julio Castro	Uruguay
Wreksoatmodjo	Indonesia
Kovaljov	USSR
Nefolovhodwe	South Africa
Lastuwka	Czechoslovakia

One of these persons is being detained in your country. I have a great interest in your country and therefore I am deeply shocked by these tidings. I would ask you to do everything possible to bring about the release of these prisoner of conscience.

I understand that Amnesty International has been asking for the release of these prisoners on several occasions. I completely agree with the request of Amnesty International with respect to these prisoners. I am convinced that you, too, will recognize the right of free speech and the right to a life in accordance with one's conscience, as laid down in the Universal Declaration of the Human Rights.
